

## Policies followed at Airaa

- monitor progress and support learning
- guide future planning, teaching and curriculum development



- inform parents and the wider community of pupil achievement
- provide information to ensure continuity when the pupil changes school or year group
- comply with statutory requirements

**h.Community Work:** Through regular PTM, take Support and interact with Parents, in different areas to ensure learner get the right atmosphere in both home and school.

**i.Extended Provisions:** Airaa provides varied areas for the holistic development like having Open houses, Clubs, sports and other scholastic and co scholastic inter house and intra house completions.
